
Dear Superintendent Lee,

The Lee School Committee has approved the following three-year tuition agreement between the Lee Public Schools and the Farmington River School District (Grades 7 - 12) to cover the districts through FY28.


- For the 2025-2026 school year, the tuition rate will reflect a percentage increase based on CPI from January 2025; amount/percentage to be determined. Tuition increases over subsequent years will be based on the Not Seasonally Adjusted (NSA) Consumer Price Index for the past twelve (12) months in January of 2026 and 2027 respectively via the Department of Labor (which can be found at <https://www.bls.gov/cpi/>).
- The 2025-2026 cost for special education students will reflect a percentage increase based on CPI from January 2025; amount/percentage to be determined. Services will be provided according to the IEP determination and recommendation of the Special Education Director. Future increases will reflect those as calculated for general education students. The rate will be based on the percentage of general education and special education services. Tuition increases over subsequent years will be based on the Not Seasonally Adjusted (NSA) Consumer Price Index for the past twelve (12) months in January of 2026 and 2027 respectively via the Department of Labor (which can be found at <https://www.bls.gov/cpi/>).

This updated formula will allow for better planning for all parties in determining tuition out-takes and in-takes from year to year. We look forward to our continued relationship in the education of our students.
